The Changing Landscape of Online Education (CHLOE 8) Report (2023) asked institutions about their communication of quality assurance practices.




Figure 33. Keeping Quiet About Quality: Institutional QA Practice vs. Communication (Sample = 266)




Quiet Quality

The report coined an institution's lack of communication of quality assurance efforts as "quiet quality." Some of the reasons that CHLOE identified for quiet quality included:

- Not a common practice
- Limited QA implementation or QA policies
- Concerns that QA is not practiced throughout the institution
- Lack of data collection, analysis, and reporting
- Lack of staff to support QA or QA analysis initiatives








What is the Online Learning Excellence Framework?

The Online Learning Excellence Framework is a set of research-based guidelines for designing and delivering high-quality online courses. It outlines the foundational elements required for an online course at UM that contribute to an engaging and effective learning experience.

The Foundational Elements of the framework focus on critical aspects such as

- Learning goals, alignment, and assessment: Ensuring that instructional materials, assessmer activities are aligned with the course learning outcomes.
- Learning activities and materials: Ensuring students have opportunities for practice and are variety of instructional materials to increase engagement and enhance learning.
- Instructor presence and student support: Ensuring instructors provide timely and consistent throughout the course and venfying that students are provided with information about stud resources.
- Course design: Ensuring the course is easy to use and accessible.
